Shareholder Communications Policy

Purpose of this Policy

The Board is committed to the promotion of investor confidence by ensuring that trade in its securities takes place in an efficient, competitive and informed market.

The Company recognises the value of providing current, relevant information to its shareholders and empowering its shareholders through effective communication.

This Policy outlines the processes through which the Company will endeavour to:

- (a) ensure timely and accurate information is provided equally to all shareholders and the broader market; and
- (b) provide reasonable means for shareholders access and put queries to the directors and management of the Company.

The Managing Director/CEO and the Company Secretary have the overall responsibility for communication with shareholders.

Types of communication

1. Full year and half year reports

The Half Year Report, Full Year Financial Statements and Annual Report are the most important media through which shareholders will be provided with a detailed review and analysis of the Company's objectives and performance.

The Half Year Report must be reported to ASX by mid-March each year; the Full Year Financial Statements must be reported to ASX by end-September each year; and the Annual Report must be lodged with ASIC and ASX by the end of October each year. The Annual Report will be sent to shareholders, other than those who have elected not to receive it.

2. Quarterly reports

Each quarter, an update of operational performance, cash flow and any other significant items will be issued to the market. A quarterly report will be lodged with ASX immediately the information is available, and in any event within 1 (one) month after the end of each quarter of its financial year, i.e. by 30 April, 31 July, 31 October and 31 January each year.

3. Announcements to ASX

- (a) The Company will immediately notify the market of, by announcing to ASX, any information or any major development related to the business of the Company which a reasonable:
 - (i) person would expect to have a material effect on the price or value of its securities; or
 - (ii) investor is likely to use as part of the basis for making investment decisions (inside information).

	<p>(b) Announcements to ASX will be made in accordance with the requirements of the ASX Listing Rules and the Company's Continuous Disclosure and Market Communications Policy. The Continuous Disclosure and Market Communications Policy sets out the Company's policy for:</p> <ul style="list-style-type: none"> (i) the disclosure of material information on a timely basis; (ii) authorised spokespersons; (iii) procedures for making announcements; and (iv) investor briefings, analyst briefings and responding to analyst reports. <p>(c) A copy of the Company's Continuous Disclosure and Market Communications Policy can be obtained from the Company's website.</p>
Shareholder meetings	<p>(a) The Company encourages and supports shareholder participation in general meetings. The Company will provide means of opportunity to shareholders to put questions to the directors and management at general meetings. Shareholders who cannot attend general meetings will be provided the opportunity to submit written questions to the Company before the meeting.</p> <p>(b) Mechanisms for enabling shareholder participation will be reviewed regularly to encourage the highest level of participation and include:</p> <ul style="list-style-type: none"> (i) notices of meeting being prepared, and meetings being conducted, in accordance with industry best practice and the guidelines published by the ASX Corporate Governance Council; and (ii) the use of electronic communication to disseminate information relating to meetings.
Auditor's report	<p>The Company will request the external auditor to attend the annual general meeting and be available to answer shareholder questions about the conduct of the audit and the preparation and content of the auditor's report.</p>
Access to management	<p>The Company will provide shareholders and potential investors with reasonable access to the Managing Director/CEO and the Company Secretary for the purposes of obtaining additional information and making enquiries related to the Company and its operations. All responses will be subject to the Company's Continuous Disclosure and Market Communications Policy.</p>
Electronic Communication	<p>The Company acknowledges that communicating with its shareholders by electronic means is an efficient way of distributing information in a timely and convenient manner, particularly through its website.</p>

All information disclosed to the ASX (except announcements of a procedural nature that have no material effect on the Company) will be placed on the Company's website as soon as it is disclosed to and acknowledged by the ASX, and will be maintained on the Company's website.

When analysts are briefed on the Company's activities, the material used in the presentation (if not previously released) is released to the ASX and placed on the Company's website.

All information contained on the Company's website will be continuously reviewed and updated to ensure all information is current, or appropriately dated and achieved.

Whenever possible, the Company will use email to communicate with shareholders who wish to receive communications in electronic form. Shareholders may register at the Company's website in order to receive links to important information by email, such as Company reports and ASX announcements.

Updating this Policy

The Board will be responsible for monitoring and updating this Policy. This Policy will be updated as and when required, including when it is appropriate to ensure that technological advances and additional features on the Company's website are utilised in the Company's communication with its shareholders and are recognised in this Policy.

Definitions

In this policy:

ASX means ASX Limited ACN 008 624 691 or the securities exchange operated by it (as the case requires).

Board means the board of the Company.

Company means International Cobalt Resources Limited ACN 624 721 035.

Company Secretary means the person appointed company secretary of the Company.

Director means a director of the Company.

Executive Technical Director means the Director appointed as the executive technical director of the Company.

Listing Rules means the listing rules of ASX.

Managing Director/CEO means the managing Director (or if there is no managing Director, the chief executive officer or Executive Technical Director as determined by the Board) or equivalent officer (by whatever title known) of the Company.

Policy means this Shareholder Communications Policy.

Shareholders means shareholders of the Company.
